Use of CBC by other groups. Two groups have approached the CBA. Modifying contract to eliminate reference to ACBL sanctioned games. ABA will play a Wednesday morning game in the education room. Whist club of Cincinnati – Thursday aft and Sun aft also in the teaching room. We need to coordinate with OLLI and Come and Play. Use the current rent structure for all outside groups.

**Education committee** – budget request & OLLI compensation. Potter discussed the past understanding. **Motion**: Approve the 2021 Zoom expense for Education by Pam Campbell (Seconded by Steve Moese). Passes unanimously. The larger request is tabled by the Board.

The board will approach Mike Purcell and Paul Pseschang to use the \$2800 balance in the Nancy Sach's fund to support educating new bridge players.

The Board will support the Education Committee recommendation at the level we did prior to Covid-19 and will do the same this year. We ask the Education chair to confirm expected expenses in our September meeting.
